### ***Notice – Proposed Amendment of the Traffic/Parking By-law 2022-02***

This notice has been issued by the Town of Penetanguishene Public Works Department, in accordance with the Implementation of Traffic/Parking By-law Amendments Policy, to inform residents and businesses that the following changes to the Traffic and Parking By-law 2022-02 that are being proposed by Town staff.

**The following are proposed NEW definitions:**

#### **PART I DEFINITIONS**

2. For the purposes of this By-law,

**“E-Bikes”** shall mean a bicycle with an integrated electric motor used to assist propulsion that has an electric motor not exceeding 500 Watts, a maximum speed of 32 km/h, and a maximum weight of 120 kg, such as a scooter or limited speed motorcycles.

**“Pedal Assisted E-Bike”** shall mean an e-bike designed to turn on the e-bike motor to help pedal and has the appearance of a standard bicycle.

**The following is a proposed amendment to the Use of Highways:**

#### **PART II USE OF HIGHWAYS**

6. (1) No person shall drive the following, except a personal mobility device or a bicycle with all wheels less than fifty (50) centimetres (20 inches) in diameter, upon any sidewalk except for the purpose of directly crossing a sidewalk:
- E-Bike;
  - Pedal Assisted E-Bike;
  - Vehicle;
  - Motor assisted bicycle;
  - Motorcycle;
  - Motorized snow vehicle;
  - Motor vehicle.

### Section 22 (1) - Schedule F – Designated Turning Lanes

The following highways set out in Column 1 of Schedule “F” of this By-law having been divided into clearly marked lanes for traffic, the lane identified in Column 2 is hereby designated only for turns in the direction indicated in Column 4 made by vehicles proceeding in the direction specified in Column 3 and the driver of each vehicle shall turn only in the direction indicated on the signs.
