# PENETANGUISHENE 55+ Centre TERMS & CONDITIONS

Registering for a Penetanguishene 55+ Centre membership constitutes acceptance of the Terms and Conditions contained herein and attached hereto.

**MEMBERSHIP TERM:** For the first round of memberships, the term will be September 3, 2025 - March 31, 2026. Future memberships will be April 1 - March 30 annually, and members must renew each April to keep their membership active.

**AGE OF MEMBERS:** The Centre's programming has been developed to serve the best interest of participants aged 55+ but the age requirement is flexible, allowing members younger than 55 to join. Please contact the Recreation & Community Services Department if you have any questions.

## **BENEFITS TO PENETANGUISHENE RESIDENTS ONLY**

- Priority or early registration for high demand programs, as indicated.
- Eligible for the "Access to Affordable Recreation Subsidy" - *contact Recreation Admin for more info.*

**ADDITIONAL FEES:** Members will be given access to specialized and instructor led programs and events at a reduced fees, as indicated through the schedule, signage, or registration. Fees may be paid by cash or by multiuse "punch" cards, ex. 5 fitness class punch card.

Programs with Registration Required: For some specialized or instructor led programs (ex. Aquafit), registration will be required. Registration for these programs can be done online through RecDesk by selecting the special reduced fee for members during checkout or in person with staff support.

**NON-MEMBER DROP-IN:** Select programs allow for NON-members to drop-in at an applicable fee. When attending a drop-in program with an additional fee for members (ex. fitness classes), non-members will pay a higher fee than members.

**LIMITED SPACE** Each program is assigned a maximum # of participants. Once a class has been filled, interested registrants can join a waiting list in order of the date registrations are received. Registrations will be accepted until the class is full, and late registrations are welcome, but subject to availability. Registration fees will not be pro-rated or altered based on late registration.

**PARTICIPANT BEHAVIOUR** Our programs are committed to providing a safe and respectful environment for all participants. Therefore, any form of physical violence or aggression will not be tolerated. Unless explicitly required by the program (e.g., ball room dancing), there should be no physical contact between participants unless consent is given. Both program instructors and participants should feel safe and free from any sense of threat or intimidation at all times. In instances where a participant demonstrates undesirable behavior common to age related cognitive conditions, a warning may be issued before considering removal from the program or facility. Our aim is to support all participants while maintaining a safe and inclusive environment for everyone involved.

The Town of Penetanguishene will charge an administrative fee of \$45.00 for cheques that are returned to us by the bank. ## **MEMBERSHIP REFUNDS**

- Membership refunds are approved on a case-by-case basis. All approved membership refunds are prorated based on the percent of the term remaining at the time of the refund request., which must be submitted by email or in person.
- Refund requests will not be approved if less than 75% of the term remains. Please allow 2 to 3 weeks to process refunds.

Refund method #1 - Electronic Funds Transfer (EFT): A deposit for the prorated refund amount minus a \$20.00 administrative fee per person is deposited into your bank account. a completed EFT form and direct deposit slip must be submitted to [finance@penetanguishene.ca](mailto:finance@penetanguishene.ca). Please allow 2 to 3 weeks to process refunds.

Refund method #2 - Account Credit: A credit for the prorated refund amount will be added to your household account. This credit can be used towards future membership or recreation program registration through the Town of Penetanguishene.
